# Privacy Policy

#### 1 Introduction

This privacy policy (the "Policy") applies to Prompt Sapper, promptsapper.tech, aichain.store and aichain.online websites (collectively "Prompt Sapper"). Prompt Sapper is an AI chain integrated development environment (IDE) that provides fundamental supports for AI chain engineer to develop, share and trade their AI services through our visual programming tool and marketplace.

As used in this Policy, "personal data" means any information that relates to, describe, could be used to identify an individual, directly or indirectly.

Applicability: This Policy applies to personal data that Prompt Sapper collects, uses, and disclose and which may includes: (1) data collected through the Services; (2) data collected through the Prompt Sapper, aichain.store, promptsapper.tech and aichain.online websites; (3) data collected from third party sources. Third party sources may include, but not limited to: public datasets, commercial data sources, and the public internet.

Prompt Sapper will not collect the private API keys, include but not limited to OpenAI API keys, and your prompts.

**Changes:** We may updates this Policy from time-to-time to reflect changes in legal, regulatory, operational requirements, our practices, and other factors. Please check this Policy periodical for updates. If any of the changes are unacceptable to you, you should cease interacting with us. When required under applicable law, we will notify you of any changes to this Policy.

**Definitions:** Through this Policy, You, or Your means the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable. Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Prompt Sapper. Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

# 2 Types of Data Collected

While interacting with the Services, you may provide certain personally identifiable information that could be used to contact or identify you.

Personally identifiable information you provide may include, but is not limited to:

- User Content: When you use our Services, we may collect Personal Information that is included in the feedback that you provide to our Services.

- Cookies
- Analytics: We may use a variety of online analytics products that use cookies to help us analyze how users use our Services and enhance your experience when you use the Services.

We do not collect any AI chain and prompts information unless you agree to publish in our Marketplace. Otherwise, all AI chain and prompts will be developed and saved in your local devices. We only help to transit the data to the corresponding services (like OpenAI) to assist debugging and use.

### 3 Use of Your Personal Data

Prompt Sapper may use Personal Data for the following purposes:

- To provide, administer, maintain, improve and/or analyze our Services, including monitor the usage of our Services;
- To conduct research;
- To contact You: To contact You by email, telephone calls, SMS, or other equivalent forms of electronic communication, such as a mobile application's push notifications regarding updates or informative communications related to the functionalities, products or contracted services, including the security updates, when necessary or reasonable for their implementation;
- To provide You with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about unless You have opted not to receive such information;
- To manage Your requests: To attend and manage Your requests to Us.
- For other purposes: We may use Your information for other purposes, such as data analysis, identifying usage trends, determining the effectiveness of our promotional campaigns and to evaluate and improve our Service, products, services, marketing and your experience;
- To comply with legal obligations and legal process and to protect our rights, privacy, safety, or property, and/or that of our affiliates, you or other third parties.

Aggregated or De-Identified Information. We may aggregate or de-identify Personal Information and use the aggregated information to analyze the effectiveness of our Services, to improve and add features to our Services, to conduct research and for other similar purposes. In addition, from time to time, we may analyze the general behavior and characteristics of users of our Services and share aggregated information like general user statistics with third parties, publish such aggregated information or make such aggregated information generally available. We may collect aggregated information through the Services, through cookies, and through other means described in this Privacy Policy. We will maintain and use de-identified information in anonymous or de-identified form and we will not attempt to reidentify the information.

# 4 Sharing of Your Personal Data

We may share your personal information in the following situation:

With Service Providers, Third Party Vendors, Consultants, and other Business Partners: We
may share Your personal information with these parties in order to provide services on our
behalf, monitor and analyze the use of our services, contact You, and for the reasons stated in
the Agreement. Service Providers to monitor and analyze the use of our Service, to contact You.

- For business transfers: We may share or transfer Your personal information in connection with, or during negotiations of, any merger, sale of Company assets, financing, or acquisition of all or a portion of Our business to another company.
- With Your consent: We may disclose Your personal information for any other purpose with Your consent.
- With Law Enforcement: Under certain circumstances, we may be required to disclose Your Personal Data if required to do so by law or in response to valid requests by public authorities (e.g. a court or a government agency). To the extent we receive a request from Law Enforcement for Your personal data, we will promptly notify You and provide You with a copy of the request, unless we are legally prohibited from doing so.
- With Other Parties in order to: Comply with a legal obligation; Protect and defend the rights or property of the Company; Prevent or investigate possible wrongdoing in connection with the Service; Protect the personal safety of Users of the Service or the public; Protect against legal liability.

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for research or internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

Depending on location, individuals may have certain statutory rights in relation to their Personal Information. For example, you may have the right to:

- Access your Personal Information
- Delete your Personal Information
- Correct or Update your Personal Information
- Withdraw your consent to the processing of your Personal Information where we rely on consent as the legal basis for processing.

We don't sell or share Personal Information as defined by the California Consumer Privacy Act, as amended by the California Privacy Rights Act. We also don't process sensitive personal information for the purposes of inferring characteristics about a consumer.
